

SAC air and ground attacks kill 9 civilians, injure 54 in Pekhon, Pruso, Loikaw and Pasaung townships

During June, SAC airstrikes, shelling and gunfire killed nine civilians and injured fifty-four in Pekhon, Pruso, Loikaw and Pasaung townships. Most of the shelling was concentrated in eastern Pekhon, where a joint force of about 500 SAC and allied PNO troops have been advancing southwards, east of the Pekhon Lake, torching local houses along the way. The SAC continued targeting the Mawchi mining area, where there is no active fighting, carrying out a deadly airstrike on June 25 that killed seven civilians and injured over forty others.

On June 6, at 6:30 am, as SAC and People's Militia (PNO) troops advanced southwards on the eastern side of Pekhon Lake, they launched four mortar shells at nearby villages, killing a 19-year-old student in Nan Pao Long village while he was studying and destroying four houses.

On June 7, at approximately 7 pm, four houses in Daw Paw Kuu village were destroyed and a 7-year-old student was injured when 6 mortar shells were fired by LIB 422 based in Pekhon.

June 9, at 10 pm, a 10-year-old boy and a 34-year-old man were injured and two houses in Lahe Sanpya village, one of the villages east of Pekhon Lake in Pekhon Township were destroyed by heavy weapons fired by the SAC troops based in Pekhon.

On the same day, the SAC and the People's Militia (PNO) launched a bomb by drone on the Kayan New Land Party (KNLP) gate in Saung Nan Khae village, east of Pekhon Lake, injuring two KNLP soldiers and killing one.

On June 10, at 8:30 am, three villagers living in Htei Klu Daw village, Pruso Township, were returning home when they were shot at by SAC soldiers who were on a patrol. Two of them were seriously injured and one has gone missing.

On June 14, at around 2 pm, two artillery shells were fired by SAC LIB 427 based in Demawso, damaging a house and some school buildings in a village in Nam Meh Khon, Demawso Township.

On the same day, the SAC LIB 422 based in Moebye fired seven artillery shells at a village west of Moebye town, injuring two men and damaging a house.

On June 16, at around 11 am, the SAC and the People's Militia (PNO) attacked the Charity Monastic Education Association School in La-Ei village, Pekhon township, with 120 mm heavy weapons and two suicide drones, injuring three students and damaging the school buildings.

On June 22, at 5:30 pm, five 60-mm shells launched by SAC LIB 530 located in Loi Le Lay town landed in a village east of the town, resulting in injuries to four civilians: two males aged 18 and 14, and two females aged 36 and 19.

On June 23, beginning at 11 am, the SAC forces stationed in Moebye and Pekhon towns fired a minimum of 30 artillery shells at villages located in Moebye and in the eastern part of Pekhon, resulting in damage to residences.

On June 24, the SAC launched heavy artillery and aerial bombardment on the eastern part of Pekhon, where fighting was intense, and more than 30 houses in Saung Nan Khae village were burned down and destroyed by the SAC and the People's Militia (PNO).

On June 25, at approximately 11 am, a SAC reconnaissance aircraft conducted a flight over the Mawchi mining region of Pasaung Township, where there was no conflict, then 15 minutes later,

a SAC aircraft dropped a bomb on the area, resulting in the deaths of 7 civilians and injuring over 40. Over 20 homes and tents were also destroyed.

On June 29, at around 3:00 pm, two artillery shells fired by the 422 LIB killed a 60-year-old woman who was coming back to check her home in the Myo-ma Ward of Moebye Township and damaged a house.
