



SAC air and artillery attacks kill 21 civilians, injure 43 in Pekhon, Loikaw, Demawso and Pasaung townships

After recapturing the town of Moebye from resistance forces on July 1, 2025, the SAC has stepped up air and artillery attacks in Pekhon, as well as Loikaw, Demawso and Pasaung townships, killing 21 civilians and injuring 43 others during the month of July. These attacks appear aimed at securing the supply routes into northern Karenni, and, in the case of Pasaung, where airstrikes targeted the Mawchi mining area, at disrupting resistance income from the mines.

On July 2, at 11:15 am, the SAC conducted a drone strike in Noe-Koe village, Loikaw township, resulting in damage to a residence in the area.

On July 2, at approximately 11:30 pm, the SAC dropped two 500-pound bombs from the air on a village in the western area of Demawso township, damaging a farmer's peanut field.

On July 4, at 5:45 pm, the SAC's Loikaw-based 260 LIB fired six artillery shells into Saw-Ke Daw village in Loikaw township, damaging a house and a toilet.

From July 3 to the evening of July 6, the SAC invaded Moebye township on the Shan-Karenni border and burned down more than 20 houses in the town. On the night of July 6, the Military Council dropped two 200-pound bombs on an area in the western part of Pekhon township, injuring a man.

On July 7, at around 10:30 am, the SAC's Loikaw-based 260 LIB fired three artillery shells into Saw-Ke Daw village in Loikaw township, damaging a house and a kitchen.

On July 7, at 11 pm, the SAC released three 200-pound bombs on an internally displaced persons (IDP) camp located in the western area of Pekhon township, resulting in the deaths of three parents in their twenties along with their 4-year-old child, and injuring five others.

On July 9, at 7:30 pm, the SAC targeted Lo Law Hti village, Mawchi area of Pasaung township with bomb strikes, which led to the deaths of five family members: two girls aged 3 and 8, a man and woman aged 28, as well as a 57-year-old woman, while injuring 9 more individuals. Six houses, along with a church and a temple, sustained damage.

On the morning of July 12, the SAC's LIB 261, based in Loikaw, shelled villages along the Loikaw-Moebye main road using heavy weaponry. One IDP was injured.

On July 12, at approximately 1 am, the SAC conducted three airstrikes employing five 200-pound bombs on the western area of Demawso township, resulting in injuries to two local men and causing damage to two houses, a car, a toilet, and a bathroom.

On July 14, at around 1 am, the SAC released four 200-pound bombs and three 500-pound bombs, totaling seven bombs by air, on three sites in the western area of Demawso township, injuring two men in their 20s and damaging some farmland, two buildings and a vehicle. On the same day, two men were shot on sight by the SAC near Solasen village, Law Pi Ta village tract while driving a motorbike travelling from Shadaw township to Loikaw. One died and one was arrested.

On July 14, at 2 pm, the SAC carried out an airstrike by using two bombs on the Mawchi area of Pasaung township, killing two men and five women, injuring 10 others, and destroying six houses.

On July 15, at around 1 am, the SAC carried out an airstrike on the Mawchi area of Pasaung township again, injuring six civilians, including five women and one man, and destroying one house.

On July 17, at 1:15 pm, at least ten bombs were released on the western area of Demawso township, causing damage to one home, a school building and some agricultural land.

On July 17, at around 10 am, a 30-year-old man from Nam Meh Khon township lost a leg and died after stepping on a landmine while searching for bamboo on Mount Sin-hthi.

On July 18, at 12 pm, the forces of SAC stationed in Pekhon, Loikaw, and Loi Lin Lay launched heavy artillery at villages on the eastern side of Pekhon, resulting in the deaths of 2 women and 3 men, injuring 7 others, and causing damage to multiple homes and church buildings.

Since July 22, SAC troops have been advancing from the Moebye-Loikaw road towards Demawso township, burning down village houses in the west of Loikaw township.

On July 25, at around 11 pm, the SAC troops fired at least 7 artillery shells into the western area of Demawso township. The SAC troops continued to advance by firing and using artillery shells and drones near Nam Meh Khon and Demawso township.

On July 26, at around 3 pm, the SAC's 102 LIB fired 3 artillery shells in the western side of Demawso township, damaging some corn fields and a house.
