

Escalated junta air and artillery attacks kill 13, injure 17 civilians in Demawso, Pekhon and Pasaung townships

During November, the junta has intensified air and artillery attacks in Demawso, Pekhon and Pasaung townships, killing thirteen civilians and injuring seventeen others. The most lethal airstrike, killing five and injuring seven in western Demawso on November 3, coincided with the advance of a junta column from Demawso towards Bawlake, and was likely aimed at protecting this column. Another series of airstrikes on November 21, killing five and injuring five others in different parts of the Mawchi mining area of Pasaung township, was probably intended to disrupt economic revenue of the resistance.

Timeline of conflict incidents during November

On November 3, at around 7 am, a junta aircraft released a bomb on a site west of Demawso, along with suicide drones and heavy artillery, resulting in the deaths of four members of the Karenni State Police (KSP) and one villager, with additional injuries to seven others.

Since November 3, the junta military has been advancing in a column through Mawkhaw Shae and Htar Lae villages towards Bawlake township, causing concern among locals and internally displaced persons about potential airstrikes and the use of drone bombs.

On November 8, at around 4 pm, a mortar shell fired by the junta military LIB 422 based in Moebye, landed in Nan Phe village (Pa-O village) in Moebye township, causing a man to lose a leg.

On November 11, junta military troops fired artillery at Ok village in the western part of Demawso township, causing explosions near the village and damaging some local houses.

On November 12, at around 3 pm, Loikaw-based military council troops fired twice at Nam San Kham village in Nam Meh Khon township, causing explosions near the village's fields and a monastery, damaging the monastery and some houses.

On November 13, around ten people were arrested by the military council on Zarat Phyu Road, Lay Mai, Loikaw township, including two men aged 28 and 30 who had fled from the eastern part of Pekhon township.

On November 15, at approximately 2 pm, a Y-12 military transport bomber from the junta executed an airstrike on Naung Hlaing village along the Shan-Karenni border, in the eastern part of Pekhon, resulting in the destruction of an old hall in the village.

On November 21, at around 9:30 am, the junta military carried out three airstrikes on various sites in the Mawchi region of Pasaung township, resulting in the deaths of five males and injuring five others.

On November 22, at approximately 11 am, the junta's troops and their allied Pa-O National Organization Army (PNO) fired heavy artillery at a field close to Baw Yan village in the western

part of Pekhon, resulting in the deaths of three out of seven female laborers displaced from Baw Yan and Nan Palo, while injuring the remaining women.

On November 23, the junta carried out airstrikes on Chi Kwe village in Bawlake township, damaging the monastery in the village, which has been deserted due to the conflict.

On November 23, at around 4 pm, junta forces carried out drone reconnaissance, launched four airstrikes, and continuously shelled a location in the western part of Demawso township, causing IDPs and locals to flee again.

On November 23, at 5 pm, the junta air force dropped two bombs on the new village of Thay Su Lae in the western part of Demawso township, destroying two houses in the village.
